## Corporate 2010

Thank you for your interest in our corporate membership category at St. Boniface Golf Club. We offer two corporate packages (see details below). The Club is located less than 4 kilometers from Portage and Main, offers excellent value for cost, and possesses a challenging well-maintained golf course. We look forward to welcoming you as a Corporate Golfer.

### Corporate Vouchers (Package A)

Corporate A Golf Package consists of 100 golf vouchers that can be used by an individual, passed on to clients and customers, or used as staff incentives and rewards. One voucher is equivalent to one round of golf when redeemed at the Pro Shop prior to play. Tee times must be pre-booked through the Pro Shop (233-4276).

#### Tee Time Bookings

Four to seven day advance booking privileges are extended to the Corporate Golfer in package A. Tee times are available between 10:00 am and 3:30 pm on Monday, Tuesday, Wednesday or Thursday. **Friday-Sunday tee times are only as available**, when booked in advance with the Pro Shop. Each corporation is limited to one tee time per day when using advance booking privileges. When booking a tee time it must be booked under the corporate name.

For tee time bookings at any other time, the following applies:

#### Charging Privileges

Charging privileges can be set up for Corporate Package A members by contacting the Clubhouse Administration staff Monday to Friday between 9:00 am and 5:00 pm.

### Corporate Membership (Package B)

Corporate Package B allows for up to five members in this category. Only one Corporate member can play per day on this corporate membership, all others playing would have to pay a green fee in the pro shop. One initiation fee and one Corporate Membership must be purchased. Each individual would pay \$150.00 food & beverage assessment which is valid until October 31, 2010. Employment verification form must be filled out to ensure all members are employed at the same company.

#### Tee Time Booking (four to seven day advance booking)

Monday to Friday – no restrictions

Saturday, Sunday and Holidays after 11:00 am.

#### Corporate A & B

- Phone bookings will be accepted at the Pro Shop starting at 6:30 am on the designated booking day.
- Tee times booked the same day as play are subject to availability without restriction.**
- Groups of five are not permitted for those utilizing corporate privileges.
