Dear Prospective Member

Thank you for your interest in our Intermediate membership at St. Boniface Golf Club. We are centrally located, offer an excellent value and possess a challenging and well-maintained golf course.

We offer an attractive competitive package to persons who are age 19 – 35 as of January 1, 2008. The clubhouse redevelopment fee is payable over a 5 year period. The initiation fee is discounted 10% for every year of Intermediate membership that the applicant may have at St. Boniface Golf Club. At the end eligible Intermediate membership, a share is required for purchase for \$100 in order for the applicant to become a full member.

EXAMPLE:

A member joining at age 22 would receive 10% off the initiation fee and once turning 35 would only be required to purchase a share for \$100 to become a non-restricted member.

A food and beverage assessment of \$300.00 is due annually and covers food and beverages purchased in the Clubhouse as well as on the golf course. Club storage, pull cart, locker and use of the exercise and practice facilities are included in membership fees.

A membership application with pricing, tee time booking conditions, membership definitions, and cart pricing package rates are enclosed to assist you in your decision to join our Club.

CLUBHOUSE REDEVELOPMENT BREAK DOWN

The Clubhouse Redevelopment Assessment is based on a five year plan. All Adult members are required to pay.

1 st Year	=	\$300.00
2 nd Year	=	\$240.00
3 rd Year	=	\$180.00
4 th Year	=	\$120.00
5 th Year	=	\$60.00

Total for the five years is \$900.00 per person. If leaving the club for a year or more you will continue where you left off on the Clubhouse Assessment payment plan.

This fee structure only applies, if you are **NOT** planning to pay for your share, initiation fee, and clubhouse assessment over five years.

St. Boniface Golf Club – 7 Day Ballot System

How it works:

The 7-day ballot system is for Members only – This includes all categories except Corporate.

- ❑ Enter ballots 7 days in advance
Example: on Wednesday you can enter ballots to play everyday up until the next Wednesday.

Draw will be made as follows:

- ❑ Saturday draw (2pm) for Monday, Tuesday, and Wednesday.
- ❑ Tuesday draw (2pm) for Thursday & Friday.
- ❑ Thursday draw (2pm) for Saturday, Sunday and Holidays.

Special Rules:

- ❑ Enter ballots at www.drivetheball.com
- ❑ You will require a 5-digit id number and password.
- ❑ Phone in tee times will still be accepted after ballot draw.
- ❑ All membership categories, except for Corporate, may use the ballot system.
- ❑ You may also phone in names for a ballot or for a tee time.

If you have any questions regarding the ballot system please ask the Pro Shop staff for assistance.

Member Guest Policy

One guest per member is allowed during the following prime times:

Maximum 3 guests per member during all other tee times.

- ❑ Green fee players will not be permitted to play following a tournament.
- ❑ Fridays will be exclusively for member enjoyment.
- ❑ Green fee players will not be permitted on Fridays except as a guest of a member.
- ❑ Tournaments or outside golf events will not be booked on a Friday.
