



Dear Prospective Member

Thank you for considering St. Boniface Golf Club as your Club. 2008 will be our 76th year in operation. Each year the golf club makes improvements to certain areas of the operation to make for a more enjoyable membership experience. This year is no different. We have enclosed a package of pertinent information, which outlines our membership criteria and fee structure.

All new members are required to purchase a share for \$100 (one time refundable fee), and pay an initiation fee of \$1000 plus GST (one time non-refundable fee). One share and initiation fee required per couple. All adult members are required to pay a clubhouse redevelopment fee of \$900.00 over five years. (See attached Clubhouse Assessment Breakdown page).

We also offer a time payment plan for new members. Pay your share, initiation fee and clubhouse assessment fee over five years charged to your Visa, M/C monthly. A yearly time payment charge of \$50.00 will apply (see last page).

CLUBHOUSE REDEVELOPMENT BREAK DOWN

The Clubhouse Redevelopment Assessment is based on a five year plan. All Adult members are required to pay.

1 st Year	=	\$300.00
2 nd Year	=	\$240.00
3 rd Year	=	\$180.00
4 th Year	=	\$120.00
5 th Year	=	\$60.00

Total for the five years is \$900.00 per person. If leaving the club for a year or more you will continue where you left off on the Clubhouse Assessment payment plan.

This fee structure only applies, if you are **NOT** planning to pay for your share, initiation fee, and clubhouse assessment over five years.

St. Boniface Golf Club – 7 Day Ballot System

How it works:

The 7 day ballot system is for Members only – This includes all categories except Corporate.

- ❑ Enter ballots 7 days in advance
Example: on Wednesday you can enter ballots to play everyday up until next Wednesday.

Draw will be made as follows:

- ❑ Saturday draw (2pm) for Monday, Tuesday, and Wednesday.
- ❑ Tuesday draw (2pm) for Thursday & Friday.
- ❑ Thursday draw (2pm) for Saturday, Sunday and Holidays.

Special Rules:

- ❑ Enter ballots at www.drivetheball.com
- ❑ You will require a 5-digit id number and password.
- ❑ Phone in tee times will still be accepted after ballot draw.
- ❑ All membership categories, except for Corporate, may use the ballot system.
- ❑ You may also phone in names for a ballot or for a tee time.

If you have any questions regarding the ballot system please ask the Pro Shop staff for assistance.
